

## ReNew+ Referral Program for East Malaysia

Welcome to ReNew+'s Referral Program for the East Malaysia ("**Program**") offered by CompAsia Sdn Bhd ("**CompAsia**"). The Program allows the existing registered users of the ReNew+ Program to earn money for successfully referring other individuals to register with the same program ("**Service**").

By participating in the Program, you agree to be bound by the following terms and conditions ("**T&C**"). If you do not agree to the T&C, we ask that you refrain from participating in the Program.

This Program will commence from [06-04-2022] until [06-05-2022] ("**Program Period**").

### Eligibility

- 1.0 This Program is open to all existing registered user of the Service who subscribed to the Service in Sabah or Sarawak ("**Referrer**").
- 2.0 In order to participate in this Program, the Referrer must ensure that the following conditions are fulfilled by the referred individual ("**Referred Person**"):-
  - 2.1 have never signed up to the Service; and
  - 2.2 individuals of or over the age of 25 years; and
  - 2.3 the Referred Person must sign up to the Service at any physical stores within East Malaysia.

### Methods of Referrals

A referral is successful when:

1. The Referrer receives a referral link ("**Referral Link**") for the Program through email and whatsapp.
2. The Referrer invites the Referred Person to register with the Service by sharing the Referral Link.
3. The Referrer must state his name and National Registration Identity Card number (NRIC) upon any application/registration made by any Referred Person.
4. Notwithstanding the success of the application/registration, the Referred Person will be rewarded with a cash voucher amounting to RM10.00 or RM15.00 ("**Referral Reward**") subjected to the terms stipulated in this T&C.

### Reward Purpose

1. All reward will be in the form of a voucher from Boost. However, CompAsia reserves the right to substitute any of the prizes with that of similar value at any time at our absolute discretion without prior notice.

2. Upon registration of the 1<sup>st</sup> to the 15<sup>th</sup> Referred Person, a Referrer will be awarded with Ringgit Malaysia Ten (RM10.00) only for each referral.
3. Subsequent registration of the 16<sup>th</sup> to the 30<sup>th</sup> Referred Person, a Referrer will be awarded with Ringgit Malaysia Fifteen (RM15.00) only for each referral.
4. The amount of total reward claimable by each Referrer is capped at Ringgit Malaysia Three Hundred (RM300.00) only.
5. These Rewards are non-transferable, non-negotiable, non-refundable and cannot be exchanged for or withdrawn in cash.

### **Redemption of Reward**

1. If you are eligible for a Referral Reward, you will receive an email and Whatsapp notification with the link to redeem the reward from Boost.
2. CompAsia reserves the right to cancel any Referral Reward without notice upon abuse or fraud of any terms and conditions of the Program by the Referrer.
3. To the extent permitted by law, the CompAsia shall not be liable for any losses or damages which occur during the redemption of the Referral Reward.

### **Termination**

CompAsia reserves the right in its sole and absolute discretion to cancel, modify, amend any aspects of the Program or this T&C at any time, without notice.

CompAsia may, in its sole and absolute discretion, terminate any Referrer or Referred Person's participation in the Program for breach of any Terms and Conditions or take any action(s) that is inconsistent with the intent of the T&C.

### **General Terms and Conditions**

1. For the avoidance of doubt, CompAsia is not obliged to confirm the registration of any Referred Person and may in its absolute discretion deny any application.

### **Privacy Notice**

1. By participating in the Contest, the Participant give their consent to and authorise the CompAsia to collect, store, use, process their names, masked Identification Numbers (IC) and other personal particulars [**"Personal Data"**] for the purpose of running the Contest, including but not limited to announcing and publishing Personal Data and/or photos of the Participant at the CompAsia's website for advertising and publicity purposes.

2. By participating in the Contest, the Participant agrees and authorise their banks to share and disclose their Personal Data to the CompAsia for the purpose to run this Contest including and not limited to the selection of Winner (if any).
3. By participating in the Contest, the Participant also give their consent and authorise the CompAsia using a third party service including but not limited to any financial institution to process the Participant's Personal Data. All such third parties are contractually obliged, not to use the Participant's Personal Data in any other than way that stated herein.
4. Under the laws of Malaysia, the rights of the Participant includes:
  - i. The rights to withdraw consent for the use of Personal Data at any time by contacting the CompAsia at the contact details mentioned below by providing the CompAsia with the Participant's name and email address for removal of the said Personal Data;
  - ii. The rights to obtain a copy of the Personal Data which the CompAsia hold; and
  - iii. The rights to correct inaccurate Personal Data.
5. The CompAsia will take reasonable precautions to keep Participant's Personal Data secure, and requires third party processors to do the same. However, the Organiser may disclose the Participant's Personal Data if required by law, search warrant, subpoena or court order.
6. Any matter to the Personal Data relating to this Contest shall be governed by and dealt with in the Personal Data Protection Act 2010 and any other relevant laws in Malaysia.
